



Establishment of the Education, Training, and Development Office at the University of Jordan Hospital: Health Knowledge Integration

Based on the vision of the University of Jordan, which recognizes knowledge as the cornerstone of progress and development in humanity today (Attachment 1), Jordan University Hospital - one of the administrative units of the university - has decided to establish the Education, Training, and Development Office. The aim is to ensure health knowledge integration, making it a global centre and reference for the development and delivery of health education and training. This is to ensure the acquisition of the necessary skills for the healthcare team to provide comprehensive medical care and preventive services according to the highest standards in education and healthcare.

The objectives of the office include training students from different medical colleges, developing healthcare professionals, and monitoring the training of residents through specialized scientific programs that are equivalent to international levels in the field. The focus is on enriching the practical skills required for the labour market, ensuring the excellence of graduates and enhancing their competitiveness in the local, regional, and global job market. The office also focuses on continuous health education programs, encompassing various healthcare sectors, to have the greatest impact on ensuring performance efficiency in the hospital, which directly reflects on the medical services provided to the community. During the COVID-19 pandemic, there was a need to train all medical staff in the hospital, each according to their role, to deal with the pandemic quickly and effectively. Therefore, training was conducted remotely using the hospital's educational platform, ensuring the completion of training and passing examinations.

This training had a positive impact on improving healthcare services and effectively reducing the spread of infections. Over 1900 hospital employees were trained (Attachment 2), and the hospital's success story led to winning the Bronze Award in the Quality Harvest Award (Hasad al Jawdeh) presented by Healthcare Accreditation Council (HCAC).

As a result of this experience, it became necessary to restructure training and unify it under one umbrella to meet local and regional needs. Significant steps were taken in 2021 when training was restructured in August 2021 at the hospital through the establishment of the Education, Training, and Development Office, consisting of three departments: Continuous Medical Education, Continuous Nursing Education and Training, and Continuous Technical and Administrative Education, and Training.

Since its establishment, the office has been working diligently and continuously with all hospital departments and units through joint cooperation and multiple committees. The office has become a fundamental unit in the hospital, with modifications made to the hospital's organizational structure to include the office and its various departments. Policies and procedures related to the new scope of work of the office have been updated. Additionally, instructions and systems have been adopted for the Education, Training, and Development Office to ensure the effective achievement of its goals according to the highest professional standards and practices.

The office has obtained various accreditations for its training programs, such as accreditation for cardiopulmonary resuscitation training programs from the American Heart Association (AHA). The process of accreditation has also begun with the American College of Surgeons for the Advanced Trauma Life Support (ATLS) course. Moreover, many training programs have been accredited as professional development hours by the Jordan Medical Council, the Jordan Nursing Council, and the Higher Health Council.

Vision:

To be a leader in education, training, and development at the local, regional, and global levels in the hospital sector.

***** Mission:

The Education, Training, and Development Office aims to enhance the skills of the hospital staff in all categories, ensuring their qualification and enabling them to provide the best healthcare and services.

Objectives:

• Enhancing knowledge and skills:

The office aims to provide continuous learning and training opportunities for all healthcare professionals, whether they are employees within the hospital or in the local community. This is achieved through organizing workshops, training courses, educational conferences, and seminars, with the aim of improving knowledge and developing the necessary skills to deliver high-quality healthcare.

• Promoting a culture of continuous learning:

The office seeks to promote a culture of continuous learning in the hospital, encouraging employees to continue developing themselves and improving their skills. This is done by providing educational resources, innovative teaching techniques, and promoting communication and collaboration among staff. The office also organizes various training programs based on the required skills and the assessment of training needs for employees.

• <u>Developing leadership capabilities:</u>

The office enhances the development of leadership capabilities for hospital staff by providing advanced training programs in management, leadership, and strategic planning. This aims to

empower employees to assume leadership responsibilities and make important strategic decisions.

• *Developing policies and procedures:*

The office works on developing and updating policies and procedures within the hospital through active participation in relevant committees, ensuring harmonious workflow with the hospital's administrative team. This aims to ensure proper guidance and coordination in delivering healthcare and achieving the highest levels of quality and safety in accordance with healthcare standards and national and international accreditation requirements.

• *Promoting a culture of scientific research and innovation:*

The office works in continuous coordination with the Office of Scientific Research and Pharmaceutical Studies to support a culture of scientific research within the hospital. This is achieved through conducting a range of training programs that cover various topics related to scientific research, contributing to capacity building and excellence.

Scope of Work for the Education, Training, and Development Office:

- Developing annual training plans based on national directives, local and global requirements to meet the training needs of hospital employees and the local community.
- Developing and enhancing policies and periodic reports related to education, training, and development.
- Implementing training programs related to the healthcare sector at all professional and academic levels in coordination with stakeholders, according to local and international standards. This includes hospital staff, students of medical and health schools, and healthcare professionals the local, regional, and global levels.

- Contributing to the organization of specialized training programs for physicians and new employees in coordination with stakeholders before the official start of work, following specialized program models.
- Working on implementing the accreditation of continuous professional development hours according to the instructions of the Jordanian councils.
- Following up with medical and administrative departments regarding the requirements of local and international accreditation standards related to the process of education, training, and development.
- Providing suggestions and ideas for improving and developing performance within the scope of work.
- Keeping up with the latest requirements of national and international accreditation standards related to education and training.

The importance of the Education, Training, and Development Office:

To ensure the enhancement of competencies in the healthcare sector, guaranteeing integration at the highest standards, and enriching practical and scientific skills to achieve the highest levels of health awareness, the office performs the following:

- 1. Managing, facilitating, and developing the process of education and training for healthcare professionals and working on its digitalization.
- 2. Obtaining local, regional, and international accreditations.
- 3. Training and developing healthcare personnel and preparing trainers at the local, regional, and global levels.
- 4. Addressing the financial challenge and limited resources through the management and facilitation of donations.

- 5. Establishing partnerships at the local, regional, and global levels in the field of education, training, and development.
- 6. Serving the local community and encouraging volunteer work.
 - 1. Managing, facilitating, and developing the process of education and training for healthcare professionals and working on its computerization.
- Developing policies and procedures that regulate and enhance the training process in the hospital.
- Establishing an online platform for delivering various training programs to all categories of staff in the hospital. This platform has played a significant role in facilitating participation in training programs and enhancing the efficiency of the workforce.
- Developing and computerizing the certification of training courses, allowing all staff members to easily obtain the certifications after approval.
- Developing and computerizing all forms related to educational and training programs, such as forms for continuous professional development hours, registration, monitoring, and evaluation.
- Developing an electronic payment process for training programs to facilitate and encourage participation.
- Preparing and training qualified and certified trainers by the American Heart Association (AHA) to enhance the efficiency of the conducted training courses.
- Collaborating with the School of Medicine at the University of Jordan by utilizing classrooms, laboratories, and training resources to enable and increase the number of training programs conducted.

- Providing the latest tools and manikins used in training programs, utilizing available
 resources, and reducing financial costs. This includes updating and developing old manikins
 to meet training requirements and international standards.
- Enhancing and improving the quality of the training process in all residency programs at the hospital by adopting the recommendations proposed in a suggestion to change the admission instructions for medical and dental specialties. These recommendations include requiring applicants to obtain Basic Life Support (BLS) certification as a mandatory requirement for application submission. Additionally, accepted residents in the residency programs must obtain certified training in the following programs, ACLS and ATLS, according to their specialization, as a mandatory requirement to fulfil admission requirements.

2. Obtaining Local, Regional, and International Accreditations

- The Education and Training Office at Jordan University Hospital is committed to excellence and efficiency in preparing specialized and accredited training programs to enhance the competency of healthcare professionals within the hospital and at the national level. This commitment is demonstrated by obtaining numerous local and international accreditations within a record time of less than a year, despite logistical challenges. This was achieved by introducing laws and systems to expedite the process, as well as establishing standards and foundations that govern and regulate this mechanism.
- The office has obtained accreditation from the American Heart Association (AHA) for Basic Life Support (BLS) and is in the process of accrediting the Advanced Cardiac Life Support (ACLS) course.
- The office has obtained accreditation from the American Heart Association (AHA) for Advanced Stroke Life Support (ASLS) to prepare trained, specialized, and competent personnel. This accreditation has a significant impact on managing and improving healthcare

outcomes for stroke cases. It also allows training for hospital staff, including physicians and nurses, as well as opening its doors to trainees from outside the hospital. Jordan UniversityHospital is one of only four accredited centers in the entire Hashemite Kingdom of Jordan that provides ASLS training.

- Initiating the accreditation process of the University of Jordan Hospital by the American College of Surgeons for the Advanced Trauma Life Support (ATLS) course to train relevant personnel within and outside the hospital.
- Accrediting 56 training programs by the Jordan Medical Council, the Jordan Nursing
 Council, and the Higher Health Council as Continuous Professional Development (CPD)
 hours for the purpose of renewing professional practice.
- Working towards fulfilling the accreditation requirements of the University of Jordan Hospital as an academic hospital by the Joint Commission International (JCI) through achieving all the standards related to education, training, and development.
- Working towards fulfilling the accreditation requirements of the University of Jordan




3. Health Workforce Training and Trainer Development

- Training 226 external trainees from the local community over 6 months on the Basic
 Life Support (BLS) course through conducting 33 accredited courses by the American
 Heart Association (AHA) (attachment 5.8)
- Training 4 certified instructors on the Advanced Stroke Life Support (ASLS) course by the American Heart Association (AHA) (attachment 5.3)

- Training 4 certified instructors on the Basic Life Support (BLS) course by the
 American Heart Association (AHA) (attachment 5.2)
- Accrediting 56 training programs by the Jordan Medical Council, the Jordan Nursing Council, and the Higher Health Council as Continuous Professional Development
 (CPD) hours for the purpose of renewing professional practice (attachment 5.4)
- Accrediting 25 residency and fellowship programs for the Arab Board by the Arab Board of Health Specializations (attachment 5.5)
- Training 76 employees in 23 external training programs, which positively impacted the efficiency of hospital staff and their utilization in training their colleagues in relevant departments on medical and laboratory equipment, as well as providing specialized nutrition specialists for chronic medical cases (attachment 5.6)
- Training 847 students and new graduates from governmental and privet universities in different hospital departments (attachment 5.7)
- Training 9200 employees at the University of Jordan Hospital on various training
 programs conducted by the Education, Training, and Development Office, which
 contributed to enhancing the competency of the workforce (attachment 5.9). This, in
 turn, reflected on performance indicators in various aspects of the hospital, including:
 - Holding infection prevention courses, leading to an increased hand hygiene compliance rate among all hospital staff to 85%, and decreased the infection rate to 1.9 % in 2023.
 - Positive reduction in high alert medication errors to 0.1%.
 - Positive reduction in medication errors to 0.2%, compared to the global standard of 0.7%.
 - Increase in hospital revenue from cardiac resuscitation courses, equivalent to
 8,675 Jordanian dinars in 6 months.

4. Addressing the Financial Challenge and Resource Limitations: Management and Facilitation of Donations

- Based on the national vision of promoting and enhancing a culture of belonging and giving at the national level, efforts were made to provide the necessary tools for training programs to enhance the efficiency of hospital staff both inside and outside the hospital. Contributions were made from within and outside the hospital to provide training equipment, such as supporting the Advanced Trauma Life Support (ATLS) course with a value of 10,000 Jordanian dinars and equipping the centre with the latest training manikins and tools.
- Internal and external support for organizing student educational activities, including
 volunteering competent and experienced instructors to deliver activities and training,
 providing training materials and manikins, and offering financial donations to accomplish
 these educational activities.
- Encouraging a sense of belonging and giving to the hospital by mobilizing efforts to support hospital employees. The hospital, through the Education, Training, and
 Development Office, ensured the provision of training programs for employees without any financial obligations on their part.
- Attracting and engaging supportive companies and sponsoring institutions to organize
 educational and training programs, as well as external conferences for employees at the
 national and international levels, without imposing any financial obligations on them.
- Addressing the University of Jordan's presidency to facilitate the donation process to the
 hospital and make it more flexible and easier to encourage and expedite the donation
 process. This includes proposing foundations and standards for managing and facilitating
 donations.


5. Establishing partnerships at the local, regional, and global levels in the fields of education, training, and development.

The Education, Training, and Development Office played a prominent role in establishing several important partnerships that provide training support services to achieve sustainable development goals at the national and global levels. These partnerships aim to establish best practices and guidelines, improve and support the capabilities and competencies of human resources based on local and international standards. Examples of these partnerships include:

- Partnership with the Jordanian Association of Ambulance and Emergency to enhance cooperation between the hospital and the association in training mechanisms related to emergency cases and training in basic and advanced first aid.
- Partnership with the National Centre for Diabetes, Endocrinology, and Genetics to train their staff at the University Hospital in accredited training programs as Continuous Professional Development (CPD) hours from the Jordanian councils.
- Partnership with the Specialized Hospital and Al Kindy Hospital to train qualified and certified instructors from Jordan University Hospital on Basic and Advanced Cardiac Life Support courses by the American Heart Association (AHA).

Supporting the partnerships established between the University of Jordan and government and private institutions by providing supervision, evaluating the training process, and enhancing the skills of their trainees in the hospital.

6. Community Service and Encouragement of Volunteer Work.



This Agreement is between the American Heart Association, Inc. ("AHA"), a New York not-for-profit corporation, having its principal offices at 7272 Greenville Avenue, Dallas, Texas 75231-4596, and ITC. IN CONSIDERATION of the mutual promises contained herein, the parties agree as follows:

1. Term: Beginning Date: March 22, 2023. Ending Date: March 22, 2025. This Agreement will be in effect for a period of Two (2) calendar years. It may be renewed for additional one (1) year periods by letter issued from AHA.

2. AHA ECC Courses to be Taught by ITC:

Basic Life Support Provider Course(s) Instructor Course(s)

3. Geographic Territory: Jordan

4. Insurance: Governnment

ITC will obtain and maintain at its expense, commencing upon the beginning date of this Agreement and during its entire term, liability insurance from a qualified insurance carrier, as set out above. This policy will specify that it may not be modified or canceled by the insurer, except after thirty (30) days prior written notice by the insurer. Upon execution of this Agreement ITC will provide the AHA with a certificate of insurance showing the required coverage.

- 5. Copyrights: ITC acknowledges and agrees that the AHA owns all copyrights in the ECC Materials, and ITC may not copy, or permit others to copy, distribute, perform or make derivative works based upon the ECC Materials, Course Completion Cards, or eCards.
- **6. Marks**: ITC acknowledges the AHA's trademark rights and ownership of the name "American Heart Association", the heart-and-torch trademark and slogans (hereinafter "AHA Marks"). ITC will not use or display the AHA Marks or any marks similar to the AHA Marks. ITC shall not apply for any trademark registrations with respect to any AHA Marks or any marks similar to the AHA Marks.
- 7. Entire Agreement: This Agreement, including the terms and conditions set out on Page Two, contains the entire agreement between the parties relating to the rights granted and the obligations assumed.

8. Definitions:

(a) "Program Guidelines" means the current Guidelines for Cardiopulmonary Resuscitation and Emergency Cardiovascular Care. Program Administration Manual: Guidelines for Program Administration and Training (hereinafter "PAM"), and AHA Instructor's Manuals, as they may be amended and/or supplemented by the AHA from time to time.

(b) "Course Completion Cards" or "Cards" are defined as documents made available or provided by AHA, and which indicate a student's successful of completion

empletion of a specified Course.

(c) "Course" or "Courses" are defined as those courses that follow the curricula of the AHA and teach emergency cardiovascular care according to the Program Guidelines.

(d) "ECC Materials" are defined as emergency cardiovascular care textbooks and materials published by the AHA.

(e) "eCards" means those electronic records that Training Centers may distribute to, or provide access to, students pursuant to Program Guidelines to indicate that the student participated in or successfully completed a Course.

"Instructors" are individuals successfully completed AHA authorized Provider and Instructor training and who are authorized by ITC to teach Provider courses to other individuals.

(g) "Training Sites" are organizations engaged or authorized by ITC to teach Courses under the auspices of ITC.

9. ITC Role and Responsibilities:

(a) ITC will teach Courses only within the Geographic Territory, and agrees to do so in with the Program Guidelines. compliance

(b) ITC may contract with other entities (hereinafter "Training Sites") who agree to teach Courses under the direction and guidance of ITC. ITC assumes full responsibility for the actions and performance of the Training Sites, and will ensure that Training Sites teach in compliance with the Program Guidelines.

(c) Periodically, as requested by the AHA, ITC will provide the AHA with a current and accurate list of Training Sites, Instructors, the number of students taught, and such other information as may be requested by AHA but only to the extent allowed by local law and the terms of any applicable consent, if required.

(d) ITC will insure that each student has individual possession of an authorized Course-specific textbook before, during, and after training.

(e) ITC will be responsible for the issuance and security of Course Completion Cards and eCards as outlined in the Program Guidelines: (i) ITC will establish a system for ensuring that Cards are issued only to authorized Training Sites. (ii) ITC and its authorized Training Sites will only issue the appropriate course-specific Course Completion Card or eCard to each student who successfully completes the applicable Course.

(f) ITC will obtain any and all required licenses, permits or documentation and is solely responsible for compliance with all laws and regulations applicable to training activities conducted under this Agreement. ITC will obtain any required or appropriate consent from each student before sharing that student's name and Course completion information with the AHA through AHA's online systems (which systems may include data storage outside of ITC's Territory) and then only if sharing that information is permitted under applicable law.

10. Relationship of Parties:

The parties acknowledge and agree that each is an independent entity and, as such, neither party may represent itself as an employee, agent, or

representative of the other; nor may it incur any obligations on behalf of the other party.

Termination:

(a) The Agreement may be terminated by either party, without cause, upon sixty (60) calendar days' prior written notice.

(b) Either party may terminate this Agreement if the other party breaches any term or condition of this Agreement and fails to cure the breach within thirty (30) calendar days after receipt of written notice by the non-defaulting party. The following will also constitute breach or default under this Agreement: (i) Failure to exist or operate as a legal entity or to maintain an office address; or (ii) Assignment for the benefit of creditors, becoming generally insolvent, being placed in receivership or the filing by or against a party of a petition for bankruptcy or for entity reorganization under any bankruptcy act or similar

(c) The AHA may terminate this Agreement upon written notice if it determines, in its sole discretion, that any of the activities permitted or contemplated under this Agreement pose a significant legal or

business risk to the AHA.

(d) Notwithstanding anything to the contrary in this Agreement, AHA may terminate this Agreement if ITC or any Training Site conducts Courses in any country on which the United States government or other governmental entity (except those that are contrary to United States' laws), that (i) imposes sanctions that would prevent the AHA conducting Courses either directly or indirectly in the country or (ii) for which ITC, Training Site or AHA must obtain a license from the applicable government to conduct Courses. If the United States government should impose sanctions on any country named in the Geographic Territory, the AHA at its option may (i) immediately terminate this Agreement as to that country in which event ITC and its Training Sites will immediately cease conducting Courses in the country, or (ii) may immediately terminate this Agreement in its entirety upon written notice to ITC.

(e) ITC will not distribute any AHA Course Completion Cards or eCards or designate itself, in any manner or any place, as an authorized ECC training center of AHA after this Agreement has been terminated or expired. In addition to any remedies by law or in equity available to AHA, ITC will pay the AHA Two Hundred Dollars (200 US\$) as a penalty for each Course Completion Card issued after termination or expiration of this Agreement. Upon termination or expiration of this Agreement, AHA shall have no liability or obligations to ITC, and ITC shall retain no rights under this Agreement.

12. Warranties:

(a) ITC warrants and represents to the AHA that as of the effective date and at all times during the term of this Agreement: (i) ITC, its agents, affiliates, members, representatives, distributors, contractors, and Training Sites will be in compliance with this Agreement, the provisions of the U.S. Foreign Corrupt Practices Act and all applicable U.S., local, state and federal laws and regulations, and applicable laws or regulations of any jurisdictions whose laws may apply; (ii) ITC is not a tobacco company, or a tobacco company corporate subsidiary or parent, nor does it receive revenue from tobacco products. "Subsidiary" and "parent" are defined as an entity in which there exists a direct or indirect Five Per Cent (5%) or greater ownership interest by a tobacco company.

(b) EXCEPT AS EXPRESSLY SET OUT IN THIS

AGREEMENT, THERE ARE NO WARRANTIES. EXPRESS OR IMPLIED. BY OPERATION OF LAW

OR OTHERWISE

13. Indemnification and Liability:

(a) ITC will indemnify, defend and hold harmless the AHA and its directors, officers, employees, agents, distributors, members, volunteers. successors and assigns from and against all suits, proceedings, actions, demands, claims, losses, liability, damages or expenses (including reasonable attorneys' fees and legal costs) arising from (i) ITC's performance or breach of its obligations under this Agreement, (ii) ITC's operation activities and/or distribution of Course Completions Cards, (iii) any breach or alleged breach of ITC's representations or warranties. (a) This Agreement may not be assigned by ITC without the AHA's prior written consent.

(b) No amendment of this Agreement will be

binding or enforceable on either party hereto unless in writing signed by both parties.

(c) Should any part, term, or provision of this Agreement be declared to be invalid, void, or unenforceable by a court of competent jurisdiction, all remaining parts, terms, and provisions hereof will remain in full force and effect, and will in no way be invalidated, impaired or affected thereby.

(d) This Agreement will be governed by the laws of the State of New York without regard to its conflict of laws provisions. Any controversy or claim arising out of or relating to this Agreement will be settled by arbitration in Dallas, Texas in accordance with the International Arbitration Rules of the American Arbitration Association, The language of the arbitration will be English. Injunctive relief may be sought in court of competent jurisdiction.




